

Google Assistant Refer a Friend Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED. VALID IN THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA ONLY.

ENTRY IN THIS SWEEPSTAKES CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES.

The **Google Assistant Refer a Friend Sweepstakes** (the “Sweepstakes”) is a Sweepstakes where participants must share a custom link with a friend that routes them to <https://store.google.com/>, and if that friend purchases via that link, they’ll be entered for a chance to win a prize. They can also be entered if the participant themselves purchase from that website via the custom URL. See below for the complete details.

1. BINDING AGREEMENT: In order to enter the Sweepstakes, you must agree to these Official Rules (“Rules”). Therefore, please read these Rules prior to entry to ensure you understand and agree. You agree that submission of an entry in the Sweepstakes constitutes agreement to these Rules. You may not submit an entry to the Sweepstakes and are not eligible to receive the prizes described in these Rules unless you agree to these Rules. These Rules form a binding legal agreement between you and Google with respect to the Sweepstakes.

2. ELIGIBILITY: To be eligible to enter the Sweepstakes, you must be: (1) a legal resident of and physically located in the 50 United States or the District of Columbia; (2) age of 18 or older; and (3) have access to the Internet or SMS device as of May 10, 2019 (“You” or “Entrant”). Participant may not enter contest if such entry would be prohibited by applicable US trade sanctions programs. Sweepstakes is void in Puerto Rico, U.S. territories and possessions, outside of the U.S., and where prohibited by law. Employees, interns, contractors, and official office-holders of Google, and their parent companies, subsidiaries, affiliates, and their respective directors, officers, employees, advertising and promotion agencies, representatives, and agents (“Sweepstakes Entities”), and members of the Sweepstakes Entities’ and their immediate families (parents, siblings, children, spouses, and life partners of each, regardless of where they live) and members of the households (whether related or not) of such employees, officers and directors are ineligible to participate in this Sweepstakes. Sponsor reserves the right to verify eligibility and to adjudicate on any dispute at any time.

3. SPONSOR: The Sweepstakes is sponsored by Google LLC (“Google” or “Sponsor”), a limited liability company with principal place of business at 1600 Amphitheatre Parkway, Mountain View, CA, 94043, USA.

4. SWEEPSTAKES PERIOD: The Sweepstakes begins at 12:00:00 A.M. Pacific Time (PT) Zone in the United States on May 22, 2019, and ends at 11:59:59 P.M. PT on June 22, 2019 (“Sweepstakes Period”).

5. HOW TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN. To enter the Sweepstakes, you meet the following criteria:

- You received a custom “Refer a friend” URL via email from Google.
- You, or someone else, makes a purchase from <https://store.google.com/> via clicking the custom URL provided by email.
- When this purchase is made, the purchaser does not clear their cache or cookies.
